RECOMMENDATION

Accept the 3Q2006 and 4Q2006 Arena Ticket Distribution Program Reports as submitted by the San Jose Arena Authority.

OUTCOME

Legislative approval by the Mayor and City Council will support the ongoing administration of the Arena Ticket Distribution Program.

BACKGROUND

As provided in the Amended and Restated San Jose Arena Management Agreement between the City of San Jose and HP Pavilion Management, the City has retained the use of sixteen (16) luxury suite seat tickets (City Box) as well as sixteen (16) seats in the Club seating level for events at HP Pavilion at San Jose. These tickets are available *solely* for municipal purposes that are specified in the Policy for Distribution of Arena Tickets adopted by the City Council. Under its agreement with the City, the Arena Authority administers the use of the luxury suite and other tickets provided to the City under the terms of the Management Agreement.

ANALYSIS

During 3Q2006 and 4Q2006 there were 77 events conducted at HP Pavilion at San Jose. From an available inventory of 2144 tickets, Arena Authority staff distributed all 2144 tickets during the two quarters for qualifying purposes. Ticket distribution for each month included the following: July, 128 tickets; August, 400 tickets; September, 384 tickets; October, 480 tickets; November, 304 tickets; and December 448 tickets. Ticket sales for the period totaled \$188.

Serving as the Responsible Party for qualifying community organizations were the Arena Authority; the City Council offices; the City Manager's Office; the San Jose Sports Authority; and Santa Clara County. It is worth noting that more than 95 organizations from the San Jose community received event tickets during the two quarters.

The Arena Authority's Ticket Distribution Program involves ongoing public outreach. It is through public outreach efforts by the Arena Authority and the City Council offices that the program continues to identify a growing number of new program recipients.

COORDINATION

This report, prepared by the Arena Authority Ticket Administrator, lists the events; Responsible Parties; users of the City Box and Club Seats tickets; the municipal purposes for each use; and the number of Club Seats tickets used or sold under the program.

With the assistance of the City Council offices, the Arena Authority continues to identify an increasing number of qualifying organizations within the ten City Council districts. During the quarter, 42 qualifying agencies and organizations recommended through the Council districts participated in the program.
