Documents Filed: Trip Report to Barcelona, Spain from Council Member Forrest Williams, dated January 14, 2005.

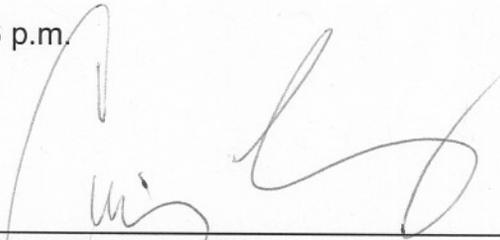
