## **RECOMMENDATION**

- (a) Adoption of a resolution declaring the results of the March 6, 2007 Municipal Runoff Election for Council District 6, pursuant to Elections Code Section 15400.
- (b) Administration of the Oath of Office to Councilmember-Elect Pierluigi Oliverio to serve the unexpired term in District 6, ending December 31, 2008.

## **OUTCOME**

Approval will allow the newly elected City Councilmember to assume Office.

## **BACKGROUND**

District 6 Councilmember Ken Yeager was recently elected to the Santa Clara County Board of Supervisors, leaving a vacancy on the City Council. A Special Election was conducted in District 6 on November 7, 2006 and no candidate received a majority of the votes cast, therefore a Runoff election was held on March 6, 2007. Pierluigi Oliverio received the highest number of votes.

## **ANALYSIS**

The County Registrar of Voters has provided the required Certificate of Election Results, Official Results and Statement of Votes for the District 6 election. Pursuant to the California Elections Code, the Council must declare Pierluigi Oliverio elected to the City Council for a term which expires December 30, 2008.

## **PUBLIC OUTREACH**

Municipal Elections are consolidated with the County of Santa Clara and held in accordance with established procedures governing the conduct of elections. Registered voters in District 6 received all appropriate ballot materials for the runoff election.

**COST IMPLICATIONS**


The cost of the runoff election was anticipated and funds are available in the Office of the City Clerk appropriation.
