RECOMMENDATION

As recommended by the Parks and Recreation Commission, name a new community center located at the 3707 Williams Road (corner of Williams and Boynton) as the "West San Jose Community Center."

BACKGROUND

Pursuant to Council Policy 7-5 the City Clerk receives nominations for naming of public facilities, which are forwarded to the appropriate Commission(s) for review and recommendation. The process calls for the Commission(s) to hold a public hearing on nominations prior to forwarding a recommendation to the City Council.

ANALYSIS

Earlier this year, a nomination was received proposing to name the community center located at the 3707 Williams Road (corner of Williams and Boynton) as the "West San Jose Community Center."

The Parks and Recreation Commission considered the matter on May 4, 2005. At that meeting, the Commission voted unanimously to name the community center, "West San Jose Community Center."


