A. City Council

C. Legislative Update

1. State

(a) AB 239 (DeSaulnier) – Counties' Right to Levy Increased Recording Fees to Fund Affordable Housing Development.

Documents Filed: Memorandum from Leslye Krutko Director of Housing dated May 2, 2007 urging the Rules and Open Government Committee to recommend to the Mayor and City Council support AB 239 (DeSaulnier).

Discussion: Leslye Krutko Director of Housing gave a brief overview of Bill AB 239. Mayor Reed said he would like to know what position the Realtors Association has taken on this bill. Councilmember Constant voiced opposition to the bill.

Action: The Committee agreed to defer a decision on AB 239 for one week and return to the Rules and Open Government Committee on May 16, 2007.

(b) AB 763 (Saldana) – Consistent and More Rigorous Notification Standards for Landlords Wishing to Convert Rental Units into Condominiums.

Documents Filed: Memorandum from Leslye Krutko Director of Housing dated May 2, 2007 urging the Rules and Open Government Committee to recommend to the Mayor and City Council support AB 763 (Saldana).

(c) AB 927 (Saldana) Required Senior Rental Housing in the Multifamily Housing Program.

Documents Filed: Memorandum from Leslye Krutko Director of Housing dated May 2, 2007 urging the Rules and Open Government Committee to recommend to the Mayor and City Council support AB 927 (Saldana).

Discussion: Vice Mayor Cortese requested that staff notify the Realtor's Association of AB 927.

Action: The Committee approved support positions for both AB 763 (Saldana) and AB 927 (Saldana) and directed staff to send the recommendations to the full Council on May 15, 2007.

(d) Photo Radar for Speed Enforcement

Discussion: There was extensive discussion around the 17 acre BAREC property on Winchester across from Valley Fair. Councilmember Constant raised several questions about the current state of the property.

Public Comments: (1) Dan Potash, Principal of Development Venture Professionals addressed Councilmember Constants questions. (2) Kathryn Mathewson and Yolanda Reynolds spoke in favor of the City acquiring the property.

Action: The Committee directed staff to prepare an informational memo on this property and the related issues.
