RECOMMENDATION

Adoption of a resolution declaring the results of the November 7, 2006 Municipal Election pursuant to Elections Code Section 15400.

OUTCOME

The resolution will certify the results of the election confirm the election of Chuck Reed to the Office of Mayor and Sam T. Liccardo to the Office of Council Member – District 3. In addition, the resolution determines the two candidates with the highest number of votes in the Special Municipal Primary Election for Council, District 6.

BACKGROUND

The City Council adopted Resolution No. 73051 on February 7, 2006 calling for a Regular Municipal Election to be held on June 6, 2006 for the purpose of electing one person to the Office of Mayor and one person each from Council Districts 1, 3, 5, 7 and 9 to the Council for full four-year terms. The resolution also requested that the County consolidate the election with the Statewide Primary. On June 20, 2006, the Council adopted Resolution No. 73246 calling for a Special Election on November 7, 2006 for the purpose of electing one person to an unexpired term on the City Council – District 6. The election was conducted and the County has certified the results of the election and provided to this Office the Certificate of Election Results, Official Results and Statement of Votes for all the contests held in the jurisdiction.

ANALYSIS

Council Member Reed was elected to the Office of Mayor of the City of San José and Sam T. Liccardo was elected to the Office of Council Member – District #3. The Statement of Votes determines the need for a Run-off Election between Pierluigi Oliverio and Steve Tedesco for the Office Councilmember – District 6. the Official Final Results, attached as Exhibit A). The complete Statement of Votes and Official Final Results are on file in the Office of the City Clerk.

All Municipal Elections are consolidated with the County of Santa Clara and held in accordance with established procedures governing the conduct of elections. Registered voters in the City of San José, Districts 3 and 6 received all appropriate ballot materials for the election.

The Election was consolidated and coordinated with the County of Santa Clara, Registrar of Voters. The Council Memo was coordinated with the Office of the City Attorney.

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE RECITING THAT A REGULAR MUNICIPAL ELECTION WAS HELD FOR THE OFFICE OF MAYOR AND CITY COUNCIL, DISTRICT 3 AND A SPECIAL MUNICIPAL PRIMARY ELECTION WAS HELD FOR CITY COUNCIL, DISTRICT 6 IN THE CITY OF SAN JOSE ON TUESDAY, NOVEMBER 7, 2006, WHICH WAS CONSOLIDATED WITH THE GENERAL ELECTION ON THAT DATE; STATING THE OFFICE TO BE FILLED AT THE ELECTION; FINDING AND DECLARING THAT THE REGISTRAR OF VOTERS OF THE COUNTY OF SANTA CLARA HAS CANVASSED THE RETURNS OF THE ELECTION, AND CONFIRMING THE RESULTS OF THE CANVASS; STATING THE WHOLE NUMBER OF VOTES CAST IN THE CITY, THE NAME OF THE PERSONS VOTED FOR, THE OFFICES THE PERSONS WERE VOTED FOR, THE NUMBER OF VOTES GIVEN AT EACH PRECINCT TO EACH PERSON; FINDING AND DECLARING THAT CHUCK REED WAS ELECTED TO THE OFFICE OF MAYOR, THAT SAM LICCARDO WAS ELECTED TO CITY COUNCIL, DISTRICT 3; AND DETERMINING THE CANDIDATES WITH THE HIGHEST NUMBER OF VOTES IN THE SPECIAL MUNICIPAL PRIMARY ELECTION FOR COUNCIL, DISTRICT 6.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1. The Council of the City of San Jose hereby finds, determines, declares and recites that a General Municipal Election was held in the City of San Jose on Tuesday, November 7, 2006 for the purpose of electing one person to the Office of Mayor of the City of San Jose and one person from Council District 3 to the Council of the City of San Jose, for a four-year term commencing January 1, 2007, and expiring December 31, 2010.

SECTION 2. The Council of the City of San Jose hereby finds, determines, declares and recites that a consolidated Special Municipal Primary Election was held for City Council, District 6 on November 7, 2006 for the purpose of electing one person

from Council District 6 to the Council of the City of San Jose, for an unexpired term ending December 31, 2008.

SECTION 3. The Registrar of Voters of Santa Clara County has duly canvassed the votes cast in the City of San Jose at the General Municipal Election consolidated with the State General Election held on November 7, 2006, by the electors of the City for the offices set forth, and has prepared a statement of all votes cast, and has certified the result of the votes cast at said election for each office, which said certification is now on file in the office of the City Clerk of the City of San Jose.

SECTION 4. The Council of the City of San Jose hereby finds, determines and declares that said canvass is confirmed, and that the following are the results of said canvass and of said election:

- (a) That the total number of ballots cast in the City of San Jose in said election is set forth in Exhibit "A", the Certificate of Election Results, attached hereto and incorporated herein by this reference; and

- (b) That the following candidates were elected to the following designated offices, each for a four-year term commencing January 1, 2007 and ending December 31, 2010:
