



**CITY COUNCIL STUDY SESSION ON
SERVICE DELIVERY MODELS
JANUARY 12, 2006**

Mayor Gonzales called the meeting to order at 8:10 a.m. and asked for a moment of silence in honor of slain East Palo Alto Police Officer Richard May.

1. Overview Presentations

Budget Director Larry Lisenbee presented the Current Budget Condition, historic information on past budget revenues, expenditures and major state budget actions from 1990-2005, ongoing cost-containment strategies, and a preliminary General Fund forecast update for 2006-2007. City Manager Del Borgsdorf continued with the factors affecting the City's current service delivery.

City Auditor Gerald Silva presented an outline of previously identified service delivery options recommended for improvement and a listing of options not yet implemented.

Dick Tracy, retired Director of Audits for the City of Portland, Oregon, presented an outline for improving services through performance measurement and reporting, citing Portland, Oregon's experience.

Ted Gaebler, City Manager for the City of Rancho Cordova, California, presented recommendations on how Council can collaboratively foster an environment for change by redeploying existing resources.

Council questions and comments followed.

The Study Session recessed at 10:44 a.m. and reconvened at 10:55 a.m.

3. Employee Panel

A panel comprised of City Staff, City Department Heads, the City Auditor and Budget Director discussed ideas for improving the City's service delivery models.

Council questions and comments followed.

4. Public Comments

There were none.

The Study Session recessed at 11:35 a.m. and reconvened at 1:06 p.m. with Council Member Yeager also absent.

5. Council Discussion

Council and stakeholder brainstorming session was held to develop methods to evaluate and improve the performance of City service delivery models. Mayor Gonzales directed staff to assimilate the brainstorming results, employee input as noted in Deputy City Manager Winer's memorandum, and New Realities Task Force Final Report, and return to Council on February 14, 2006 with the top 10 recommendations based on their long term benefits for the City.
