



**CITY COUNCIL STUDY SESSION ON
THE COYOTE VALLEY SPECIFIC PLAN
APRIL 7, 2006**

1. Opening Remarks

Mayor Gonzales called the meeting to order at 9:08 a.m. indicating that the meeting was for the purpose of reviewing transportation issues for the Coyote Valley Specific Plan and added that no action would be taken at this session.

2. Introduction

Deputy Director Prevetti presented a brief slide presentation with an overview of the Coyote Valley Specific Plan including the City Council vision and expected outcomes.

3. Regional Transportation Context

Deputy Director Larsen presented an outline of the Regional Transportation Context and noted that two VTA planning representatives were present for questions.

Council questions and discussion followed.

4. Elements of the Coyote Valley Transportation System

Deputy Director Prevetti presented a slide presentation outlining the elements of the Coyote Valley Specific Plan Transportation System which included an In-Valley transit system incorporating CalTrain, buses and trails.

Council questions followed.

5. Policy Issues

Acting Director Horwedel outlined the options for maintaining level of service, i.e., modify the existing Citywide Transportation Impact Policy, create an Area Development Policy, and create a Unique Multi-Modal Transportation Strategy. Deputy Director Prevetti presented possible transportation parameters that promote safe and efficient mobility for all modes of travel. Deputy Director Larson noted ongoing coordination between the task force, technical team and public outreach.

There were no questions from Council.

6. Next Steps

Deputy Director Larson indicated that the next Study Session to review the Coyote Valley Specific Plan Draft Fiscal Analysis will be held on April 28, 2006.
