1. Reed Reforms

2. Sunshine Reform Task Force

a. Review of remaining provisions of Sunshine Reform Task Force Phase 1 Report and Recommendations.

Documents Filed: 1) Current Noticing Practices of San José Boards, Commissions and Advisory Committees; and 2) Listing and description of San José Boards, Commissions and Advisory Committees; and 3) Memorandum from Communications Director Tom Manheim dated October 18, 2007 recommending that the City review and make recommendations on the remaining provisions of the Sunshine Reform Task Force's Phase I Report and Recommendations.

Discussion: Communications Director Tom Manheim provided an overview of the handouts. The Committee reviewed the Sunshine Reform Task Force (SRTF) recommendations for policy bodies, as applied to City boards and commissions. Assistant RDA Abi Maghamfar, Housing Director Leslye Krutko, Deputy Directors of Parks, Recreation and Neighborhood Services Cynthia Bojorquez and Julie Edmonds-Mares summarized current practices and challenges for advisory bodies their offices support.

SRTF Chair Ed Rast commented that the availability of audio recordings within a reasonable amount of time following meetings would make minutes less necessary. He added that the public desires reasonable notification and access to meeting documents available on-line.

Actions: The Committee tentatively agreed to the following requirements for City boards and commissions: 1) 7-day standard for posting regular meeting agendas and related staff reports; 2) distribution of supplemental memos – same as Council Committees; and 3) 4-day standard for posting special meeting agendas. The Committee agreed to continue the discussion beginning with recording requirements at the next meeting, as well as applying the SRTF recommendations to “standing” or “other” committees. The Committee also expressed an interest in understanding the difference between “minutes” and “synopsis”.

3. Significant Public Records Act Requests

Discussion: San José Police Captain Gary Kirby provided an oral report on the Department's response to a request for records as part of survey conducted by CalAware, as reported in the Mercury News. Brief questions followed regarding copying fees. Captain Kirby noted that the SRTF was considering a recommendation relating to a standard, citywide copy fee.
