**A RESOLUTION OF THE COUNCIL OF CITY OF SAN JOSE
SETTING FORTH THE SCHEDULE OF PARKING PENALTIES
AND LATE PAYMENT PENALTIES FOR PARKING VIOLATIONS
AND REPEALING RESOLUTION NO. 73338, EFFECTIVE
MARCH 1, 2009**

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1. SCHEDULE OF PARKING PENALTIES

The following parking penalties are hereby established for violations of San José Municipal Code and California Vehicle Code regulations:

Section 2. LATE PAYMENT PENALTIES

1. Late payment penalties shall be added to the Total Penalties as follows:
A one-time late payment penalty of thirty dollars (\$30.00) shall be added if the Total Penalty has not been paid within ten (10) days of the mailing of the notice of delinquency.

Section 3. DEPARTMENT OF MOTOR VEHICLES SERVICE FEE

2. A service fee for unpaid parking penalties shall be added to the Total Penalties as follows:
A one-time service fee of three dollars (\$3.00) shall be added if the Total Penalty has not been paid within forty (40) days of the notice of parking violation and a hold has been placed on the vehicle registration through the Department of Motor Vehicles.

Section 4. CREDIT CARD SERVICE FEE

1. A one-time service fee of three dollars (\$3.00) for parking penalties paid by credit card shall be added to the Total Penalties, which shall be collected by the City or by the City's Parking Citation Processing and Collection contractor, to defer the cost of processing and collecting credit card payments.
