RECOMMENDATION

Staff recommends the appointment of Mr. John Salah, Airport Commissioner for Norman Y. Mineta San Jose International Airport to the Airport Noise Advisory Committee.

OUTCOME

Upon appointment, Mr. Salah will begin his new role at the next meeting. This meeting will be scheduled during the third quarter of 2009.

BACKGROUND

The Airport Noise Advisory Committee (ANAC) for the Mineta San José International Airport is an advisory body where aircraft operations and procedures are reviewed and/or generated in the interest of mitigation of noise impacts on the environs. The committee meets on a quarterly basis and serves as a source of information to the community to increase their knowledge about the Airport and airline operations.

San José City Ordinance 25.04.610 designates specific representation on the Committee, and requires Council appointment for ANAC membership. The ANAC member representing the Airport Commission term has expired with an effective date of June 01, 2009.

ANALYSIS

Based on the San José Municipal Code Section 25.04.610, the Committee must consist of one Airport Commissioner to serve as the Chairperson. The Commission appointment of Mr. Salah to serve as the next ANAC Chairperson was nominated and voted on at the Airport Commission meeting that was held on August 10, 2009.

Appointment of Mr. Salah satisfies the requirements of the San José Ordinance governing the ANAC and its membership.
