



**MINUTES OF THE CITY COUNCIL

Welcome and Background

Mayor Reed provided opening comments.

City Budget and Policy Issues Affecting Airport Competitiveness

Director of Aviation William Sherry provided the Staff presentation on the following issues: (1) Competing in the Marketplace, the Airport as a self supporting business; (2) National and Bay Area air service market trends; (3) Cost per enplanement, what it is and why it is important; (4) Airport budget issues; (5) Challenges to effectively compete in the marketplace; (6) Strategies to address marketplace challenges; (7) Tale of two airports, possible future trends, and (8) Where do we go from here.

Extensive Council discussion followed.
