City Attorney Richard Doyle offered clarification and comments.

Council Member Liccardo requested to amend his motion to include the requirement that the substitution be in writing (not waived). Council Member Herrera accepted the amendment.

Action: On a call for the question, the motion carried unanimously, the report on bids and, subject to staff's evaluation of any protests and further report to City Council was accepted, the award of contract for the San José Environmental Innovation Center (Project) ReBid to the lowest bidder, Applegate Johnston, Inc., to include the base bid of \$10,624,000 and Add Alternates #1 and 2 in the amount of \$470,935, including the requirement that the substitution be in writing (not waived), and the third amendment to
