RECOMMENDATION

1. Interview applicants for appointment to the Appeals Hearing Board
2. Appoint one (1) member to the Appeals Hearing Board to the balance of an unexpired term expiring December 31, 2013.
3. Appoint two (2) members to the Appeals Hearing Board to full three-year terms expiring December 31, 2014
4. If any vacancy remains, direct the City Clerk to continue recruitment efforts and bring additional applicants forward for consideration within 90-days

BACKGROUND

Under San Jose Municipal Code Section 2.08.620, the Appeals Hearing Board has the following functions, powers, and duties:

- A. Hear all administrative hearings and appeals authorized by this Code or by ordinance.
- B. Conduct all administrative abatement action hearings authorized by this Code or by ordinance.
- C. Perform the functions and duties within the jurisdiction of the code enforcement appeals commission as set forth in other titles of this Code.
- D. Perform such other programs or functions related to administrative hearings and appeals that the city council or the city manager may, from time to time, authorize or request.

There are currently two (2) vacancies on the Appeals Hearing Board. Commissioner Judith Jones resigned and her term expires December 31, 2013. Commissioner Jose Hernandez resigned and his term expires December 31, 2011. Both Commissioners provided exemplary service but have resigned for personal reasons. The Office of the City Clerk conducted an open recruitment from July 11, 2011 through September 9, 2011.

In addition, Edgar "David" Parker, appointed to the Board on February 1, 2011 to a term expiring December 31, 2011, has filed his application for re-appointment.

The Office of the City Clerk received eight applications which were submitted to the Mayor and City Council for their review. Each Council member was asked to give an "indication of interest" of applicants to be interviewed. Any applicant receiving interest from four or more Councilmembers will be considered in the interview process. This procedure is consistent with the Council's direction regarding appointments to specific City Boards and Commissions.

ANALYSIS

Five (5) applicants received indications of interest from four or more Councilmembers and have been invited to be interviewed by the City Council on October 4, 2011. As required by the Municipal Code, a successful applicant must receive six (6) or more votes to be appointed to the Appeals Hearing Board. If any seat remains unfilled, it is recommended that the recruitment be referred back to the City Clerk to secure additional applicants for consideration by the Council in 90-days. After the interviews, the Council may make up to three appointments to the Commission:

- To fill one (1) unexpired term ending December 31, 2013 and
- To fill two (2) three year-terms expiring December 31, 2014.

Interview Order:

The applicant interview order was determined by using the California Secretary of State's Randomized Alphabet Drawing for the November 2010 election ballot. This method is consistent with the process used in scheduling interviews for other boards and commissions. Applicants will be sequestered in another location so that they may not view or hear the interviews of other applicants until they are called to appear. The interview order is:

Information from the Office of the City Attorney and the Department of Planning, Building, and Code Enforcement regarding their review for potential conflicts will be issued via a supplemental memorandum.
