#### C. Legislative Update

#### 1. State

Director of Intergovernmental Relations Betsy Shotwell informed the Committee that the State legislature is adjourning the legislative session on Friday, August 31, 2012. Ms. Shotwell stated that the Governor has announced a pension agreement and Charter cities such as San Jose and San Diego are not affected.

Mayor Reed stated that he's read several versions of the bill and talked with the Governor's staff, but until the bill is passed, we won't know what it is. He expressed that the plan will have a positive impact on the City of San Jose by closing the competitive gap as the State increases the retirement age, slows accrual rates, and requires State and local employees to pay more for their retirement benefits, which is what San Jose has done with Measure B.
