

ORDINANCE NO.

**AN ORDINANCE OF THE CITY OF SAN JOSE AMENDING  
ORDINANCE NO. 28178, AS AMENDED, TO EXTEND THE  
ENDING DATE OF THE PILOT FOR THE  
NEIGHBORHOODS COMMISSION TO JUNE 30, 2013**

**WHEREAS**, on November 20, 2007, the City Council of the City of San José (“City”) approved Ordinance No. 28178, which established a Neighborhoods Commission pilot project; and

**WHEREAS**, on June 21, 2011, the City Council approved Ordinance No. 28935, which amended Ordinance No. 28178 to extend the term of the pilot project; and

**WHEREAS**, on December 13, 2011, the City Council approved Ordinance No. 29004, which amended Ordinance No. 28178, as amended, to further extend the term of the pilot project through June 30, 2012; and

**WHEREAS**, on June 30, 2012, the authority for the Neighborhoods Commission expired and the Commission has not met since; and

**WHEREAS**, on October 23, 2012, the City Council directed staff to reinstate the Neighborhoods Commission pilot project through June 30, 2013; and

**WHEREAS**, the City desires to amend Ordinance No. 28178, as amended, to further extend the term of the pilot project through June 30, 2013;

**NOW, THEREFORE**, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1. Section 1 of Ordinance No. 28178, as amended, is further amended to read as follows:

“SECTION 1. Commission Established

The Neighborhoods Commission is hereby established for a pilot period beginning June 30, 2009 and ending June 30, 2013.”

SECTION 2. Section 4 of Ordinance No. 28178, as amended, is further amended to read as follows:

“SECTION 4. Term of Office

- A. The initial members of the Commission shall be appointed for the pilot period of the Commission.
- B. Those members in place and appointed as of June 30, 2012 shall remain in place until the end of the pilot period.”

SECTION 3. The Neighborhoods Commission will submit any recommendations regarding the future of the Commission to the City Council prior to consideration of future Council action regarding the Commission.

SECTION 43. The provisions of this Ordinance shall be applied retroactive to July 1, 2012.
