AN ORDINANCE OF THE CITY OF SAN JOSE AMENDING ORDINANCE NO. 28593 TO APPROPRIATE MONEYS IN THE SUPPLEMENTAL LAW ENFORCEMENT SERVICES (SLES) FUND FOR THE SUPPLEMENTAL LAW ENFORCEMENT SERVICES GRANT 2009-2011; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON ADOPTION

WHEREAS, it has been certified that there will be available for appropriation in the Supplemental Law Enforcement Services (SLES) Fund in the fiscal year 2009-2010 moneys in excess of those heretofore appropriated therefrom, said excess being at least \$225,229;


