

**ORDINANCE NO. 28770**

**AN ORDINANCE OF THE CITY OF SAN JOSE AMENDING ORDINANCE NO. 28765 TO APPROPRIATE MONIES IN THE MULTI-SOURCE HOUSING FUND FOR THE TOXIC SUBSTANCES CONTROL GRANT; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON ADOPTION**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SAN JOSE:**

SECTION 1. Section 23.04 of Ordinance No. 28765 is hereby amended to read as fully set forth on EXHIBIT "A," entitled "AMENDMENTS TO ORD. 28765," which is attached hereto and incorporated herein as though fully set forth in this Section of this Ordinance.

SECTION 2. The provisions of this ordinance are contingent upon this Council's adoption of the fiscal year 2010-2011 appropriation ordinance, Ordinance No. 28765, which was adopted on June 29, 2010. This ordinance shall become effective immediately upon adoption, pursuant to Section 605(c) of the Charter of the City of San Jose.
