

**ORDINANCE NO. 28834**

**AN ORDINANCE OF THE CITY OF SAN JOSE AMENDING ORDINANCE NO. 28765 TO APPROPRIATE MONIES IN THE SUBDIVISION PARK TRUST FUND FOR THE NISICH PARK DEVELOPMENT PROJECT; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON ADOPTION**
