

RESOLUTION NO. 73748

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE VALIDATING POLICIES CONTAINED IN THE CITY COUNCIL POLICY MANUAL

WHEREAS, the City Council Policy Manual of the City of San José (“City”) has been in existence since August 3, 1970, and is intended to provide direction and/or guidance to City staff on how the Council wishes to have certain issues and procedures addressed; and

WHEREAS, the City administration is conducting a comprehensive review of all City Council policies and desires to validate a total of thirty one (31) policies, of which eighteen (18) policies, attached hereto as Attachment A, have recently been implemented, revised, and/or reflect current practice/Council direction; and
