

RESOLUTION NO. 73930

**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE  
TO ESTABLISH NEW QUANTITY CHARGES  
FOR POTABLE WATER SERVICE EFFECTIVE JULY 1, 2007**

**WHEREAS**, the current rates and charges for potable water service in areas served by the San José Municipal Water System (SJMWS) were adopted by this Council on June 20, 2006 in Resolution No. 73527; and

**WHEREAS**, in order to cover increases in wholesale water and other costs and expenses associated with providing potable water service costs, this Council desires to implement a 7.3 percent overall increase in potable water rates and charges for all customers of the SJMWS effective July 1, 2007; and

WHEREAS, a 7.3 percent overall increase in potable water rates and charges is consistent with Part 2.5 of title 15 of the San José Municipal Code and is necessary to generate revenue to make the expenditures required and allowed under San José Municipal Code Section 4.80.630;

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
SAN JOSE THAT:**

1. Effective July 1, 2007, the following rates and charges are established for potable water service provided by the San José Municipal Water System:

**GENERAL METERED SERVICE**

**APPLICABILITY:**

This schedule is applicable to all metered water service.

**TERRITORY:**

All of that territory located within the Alviso Water Service Area as set forth in the San José Municipal Code Section 15.08.260, Edenvale Water Service Area as set forth in the San José Municipal Code Section 15.08.265, North San José Water Service Area as set forth in San José Municipal Code Section 15.08.280 and Coyote Water Service Area as set forth in San José Municipal Code Section 15.08.275.

All consumption levels - \$1.89 per 100 cu. ft., except in the McCarthy/Dixon Zone of the Alviso Service Area, which is defined as that portion of the Alviso service area that receives water purchased by the City of San José from the City of Milpitas. Within the McCarthy/Dixon Zone, the rate shall be \$3.76 per 100 cu. ft. effective June 17, 2003; and such rate shall be indexed to the price of water sold by Milpitas to San José, such that the rate shall automatically change concurrently with and equivalent to any change in the price paid by San José to Milpitas for water.

The Service Charge is a readiness-to-serve charge, which is added to the monthly charge computed at the Quantity Rates.
