

**RESOLUTION NO. 74181**

**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING MODIFICATIONS TO THE LIST OF 24 PROTECTED INTERSECTIONS PURSUANT TO COUNCIL POLICY 5-3 TO ADD AN INTERSECTION AT HEDDING STREET AND OLD OAKLAND / 13<sup>TH</sup> STREET**

**WHEREAS**, on June 21, 2005, the City Council of the City of San José (“City”) adopted a revised Policy No. 5-3 entitled “Transportation Impact Policy,” which Policy guides analyses and determinations regarding the overall conformance of development with City’s General Plan multi-modal transportation policies; and

**WHEREAS**, Policy 5-3 acknowledges that exceptions to City’s policy of maintaining a minimum Level of Service D at local intersections will be made for certain protected intersections that have been built to their planned maximum capacity; and

**WHEREAS**, on June 21, 2005, the City Council adopted a list of protected intersections under and pursuant to Policy No. 5-3; and

**WHEREAS**, City desires to amend the inventory of protected intersections to add the intersection of Old Oakland-13<sup>th</sup> Street/Hedding Street to City’s current list of 24 protected intersections pursuant to Policy 5-3.

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

Pursuant to City Council Policy 5-3, “Transportation Impact Policy,” the City Council hereby approves the following intersection as a protected intersection:

13<sup>th</sup> Street/Hedding Street; and, after the addition of this intersection to the list of protected intersections, hereby recognizes that there will be a total of 25 protected intersections city-wide as follows:

- 15 11<sup>th</sup>/Julian
