

RESOLUTION NO. 74197

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN JOSE RENAMING THREE PUBLIC STREETS, CURRENTLY NAMED RUE ROYALE, SAINT TROPEZ DRIVE, AND ESTEREL COURT, LOCATED ON THE NORTH SIDE OF ABORN ROAD APPROXIMATELY 1000 FEET EAST OF ALTAMARA AVENUE (TRACT 9531, ORCHARD HEIGHTS III) TO JOHN SORCI DRIVE, JENNIFER DAISY DRIVE, AND JONATHAN RACHELLE COURT, RESPECTIVELY

WHEREAS, the applicant, John Moniz of Pinn Brothers Fine Homes, has requested that the subject public streets commonly known as Rue Royale, Saint Tropez Drive and Esterel Court be renamed, as follows: John Sorci Drive, Jennifer Daisy Drive, and Jonathan Rachelle Court, respectively; and

WHEREAS, said streets are currently under construction, and homes on said streets have not yet been occupied; and

WHEREAS, the United States Postal Service and the County of Santa Clara Communications Department have been notified about the proposed street renamings and have approved said street renamings; and

WHEREAS, this change therefore would be consistent with Council Policy 6-5, and would promote the welfare and general convenience of the community; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1: Pursuant to the provisions of Section 3409.1 of the Government Code of the State of California, this Council does hereby find that the public streets located on the north side of Aborn Road, approximately 1000 feet east of Altamara Avenue currently and commonly referred to as Rue Royale, Saint Tropez Drive, and Esterel Court: (1) be respectively re-named, as follows: John Sorci Drive, Jennifer Daisy Drive, and Jonathan Rachelle Court, all located in the City of San Jose and shown more particularly and in more detail on Exhibit "A", attached hereto and incorporated herein, and (2) should be so named, and the City Council does hereby rename said public streets as noted herein effective December 18, 2007.

SECTION 2: The City Clerk is hereby directed to deliver a copy of this resolution to the Board of Supervisors of the County of Santa Clara.
