

RESOLUTION NO. 74264

**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING THE DIRECTOR OF PARKS, RECREATION AND NEIGHBORHOOD SERVICES TO NEGOTIATE AND EXECUTE AGREEMENTS AND AMENDMENTS TO AGREEMENTS RELATED TO THE 2007-2008 AFTER SCHOOL PROGRAMS**

**WHEREAS**, in November 2006, as a result of passage of Proposition 49 and Assembly Bill 638, the State of California released the After School Education and Safety (ASES) program funds; and

**WHEREAS**, the City of San José ("City") currently operates After School programs at Anne Darling, Empire Gardens, and Olinder Schools in the San José Unified School District; Cureton, McCollam, Slonaker and Painter Schools in Alum Rock Union School District; George Mayne Elementary School in the Santa Clara Unified School District; and Summerdale Elementary School in the Berryessa Unified School District; and

**WHEREAS**, Alum Rock Union, Berryessa Unified, San Jose Unified and Santa Clara Unified School Districts ("Districts") applied to the State of California for program funds to operate the After School programs at the specified schools during 2007-2008, and chose the City as the best program operator for these schools; and

**WHEREAS**, the City desires to negotiate and execute agreements and any amendments to agreements relating to the provision of 2007-2008 After School Programs at the above schools, funded with up to \$1,007,991 from the Districts; and

**WHEREAS**, the City desires to negotiate and execute amendments to the agreements in excess of \$1,007,991, if the Director of Parks, Recreation, and Neighborhood Services ("Director") subject to the receipt of funds, and provided that the Director determines that the City is able to provide the program services and comply with additional requirements associated with the increased grant funds;

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The Director of Parks, Recreation and Neighborhood Services is authorized to:

1. Negotiate and execute all agreements and amendments to agreements related to the provision of 2007-2008 After School Programs funded with up to \$1,007,991 paid by Alum Rock Union, Berryessa Unified, San José Unified, and Santa Clara Unified School Districts.

2. Negotiate and execute amendments to the agreements in excess of \$1,007,991 subject to the receipt of additional funds and further provided that the Director determines that the City is able to provide the services and comply with any additional requirements associated with the increased grant funds.
