

RESOLUTION NO. 73636

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSÉ AMENDING THE CONFLICT OF INTEREST CODE FOR THE CITY OF SAN JOSE

WHEREAS, the City Council of the City of San Jose has adopted and incorporated by reference the terms of the standard model conflict of interest code adopted by the Fair Political Practices Commission (FPPC) by Regulation 2 California Code of Regulations, Section 18730; and

WHEREAS, the City Council has thereby approved a list setting forth designated positions of officers, employees, members and consultants of the City, and setting forth required conflict of interest disclosure categories; and

WHEREAS, that list should be amended and updated due to changes in organization and authority of City departments, boards, commissions and committees; and

WHEREAS, a public hearing was held on February 6, 2007 on the proposed amendments to the Conflict of Interest Code following the notice required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSÉ THAT:

1. The City of San Jose Conflict of Interest Code is amended in its entirety by this Resolution and the appendices attached hereto.
2. The Terms of 2 California Code of Regulations, Section 18730, and any amendments thereto, taken with appendices attached to this Resolution and incorporated by reference shall constitute the conflict of interest code

for all City of San Jose departments, boards, commissions and committees.

3. Persons holding designated positions listed in the attached Appendix I and consultants who are required to disclose pursuant to Appendix II shall file statements of economic interest when required by the state Political Reform Act or notified to do so by the City Clerk or designee or by the terms of an employee or consultant agreement with the City in accordance with the Act.



- 6) Reportable investments, income and business positions are limited to persons, business entities or other sources which provide airport/airline services or support airport/airline services; i.e., airport concessionaires, fixed based operators, airlines, car rental agencies, taxi cabs, limousines, ground handling services, fuel suppliers, shippers, freight forwarders and travel agencies at San Jose International Airport.

- 19) For heavy diesel equipment manufacturers and/or suppliers; for heavy equipment parts manufacturers and/or suppliers; for diesel fuel manufacturers and/or suppliers.
- 20) You must report any investment, income or interest you have involving a person, firm or business that provides material supply, provides equipment supply, performs professional services, performs construction, performs private development or provides public utility services for the City of San Jose.
- 21) You must report any interest you have in real property, which is in or within two miles of the jurisdictional limits of San Jose, other than your principal place of residence.
- 22) Business positions include any type of real estate or contractor's license, active or otherwise.

Business investments, income, and business positions are limited to persons, business entities, or other sources holding real estate interest within the applicable geographical area or whose activities involve any aspect of construction, including signs, landscaping, financing, brokerage, etc.

- 5) Reportable investments, income and business positions are limited to any persons, business entities or other sources operating or doing business within the jurisdiction served by the San Jose Fire Department.
- 6) Reportable investments, income and business positions are limited to persons, business entities and other sources which manufacture or sell firefighting and/or automotive equipment and/or supplies.
- 7) Reportable investments, income and business positions are limited to persons, entities and other sources which manufacture or sell fire prevention equipment/supplies, fire alarm equipment/supplies, firefighting equipment/supplies, computer hardware and/or software business systems services and/or related consulting services, and/or any business.

A. Consultant's Disclosure

- (1) Each "consultant" as defined by the Political Reform Act (Government Code 81000, et seq.) and the implementing regulations adopted by the Fair Political Practices Commission is required to file disclosure Form 700 with the Agency.
- (2) Only those interests which are relevant to the consultant's engagement are required to be disclosed. The appropriate interests to be disclosed shall be determined by the responsible Appointing Authority or designee, such as directors or heads of the various City of San Jose offices or departments. Appointing Authorities are those officers of the City appointed by the City Council pursuant to the City Charter. The interests to be disclosed shall be set forth in the agreement for services between the consultant and the City of San Jose.
- (3) Disclosure shall be made as to the interests of each person performing under the agreement, to the extent required by the Political Reform Act.

B. Disqualification

- (1) Nothing in this Resolution should be construed to allow any official, employee or consultant of the City of San Jose to make or participate in making or in any way attempt to influence a governmental decision in which he knows or has reason to know he has a financial interest. Disqualification in the event of a conflict of interest is governed by 87100 and following of the Government Code and the implementing regulations promulgated pursuant to the Political Reform Act.
- (2) All agreements with consultants, whether or not such a consultant is required to file a disclosure statement in accordance with this Resolution, shall provide that the consultant is obligated to disqualify himself or herself if a conflict of interest exists at any time during the term of the Agreement.
