Upon motion of Member Williams, seconded by Vice Chair Constant, the Committee accepted the report.

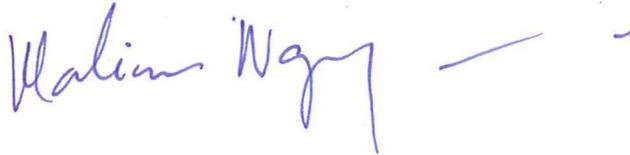
