# Parameters of Drafting the Ordinance

- The provisions in the draft ordinance are in compliance with Prop 215, SB 420 and the California Health and Safety Code. If approved by the City Council, they will not interfere with a patient's right to use medical marijuana as authorized under State Law, nor will they criminalize the cultivation of medical marijuana by qualified patients or primary caregivers.
- To the extent possible, the Administration has developed policy alternatives in areas that are not defined by law.

# Operational Framework Considerations

- City Registration Process
- Collective Management Structure
  - Includes Membership Considerations, Membership Payment Structure, Key Organizational Components, etc.
- Hours of Operation
- Outlines Safety and Security Measures
- Closed-Loop System

# Operational Framework Considerations

- Packaging Considerations for Medical Marijuana
- Sale of Ancillary and Manufactured Products or Paraphernalia Prohibited
- Records Maintenance and Independent Audits
  - Includes financials, membership records, etc.
- Personal Use Considerations and Regulations
- Sunset in Two Years



# Select Policy Alternatives

- Number of Medical Marijuana Collectives
- Membership and Management Considerations
  - Age, Residency, One Membership, and/or other Conditions
- Hours and/or Days of Operation
- Operating Regulations and Conditions
  - Prohibits the Provision of Other Services (e.g. Massage, Homeopathic Services, etc.)

# Select Policy Alternatives

- Security and Safety Considerations
  - Security Guards
- Personal Use Considerations of Medical Marijuana
  - Requirements in general for personal use
  - Up to 50 Square Feet Limit for cultivation

# Zoning/Land Use Framework Considerations

- Maximum Number of Collectives at 10
- Commercial General Zoning District
- Zoning Compliance Certificate
- No Land Use Permit
- Regulation Will be Coordinated by the Police Department

# Zoning / Select Land Use Options

- Under consideration: 1,000 feet from single and two family residential (potentially eligible sites =113 parcels)
- Offsite Cultivation at Industrial Zoning Districts
- Other Sensitive Uses for Consideration:
  - School
  - Child day care center
  - Church that includes a school or child day care use
  - Community or recreation center
  - Park
  - Trail
  - Library
  - Substance abuse rehabilitation center
  - Another Medical Marijuana Collective
