The 2011 Redistricting Advisory Commission of the City of San José convened in Public Hearing session on May 9, 2011 in the Willow Glen Community Center at 6:30 p.m.

Chair De La Rosa gave a brief update and explanation of transfer areas to the audience. He acknowledged the letters received from the community and explained the role of the Commission and provided an overview of the work that is ahead of them which is to comply with the Voting Rights Act and guidelines. He continued to talk about the Mayor's memo dated January 7, 2011 which outlines to maintain the continuity of existing Council Districts.

Commissioner Schumb gave a brief introduction and shared some of his observations and concerns.

The Public hearing continued with the presentation by Senior Planner Michael Bills.

The following residents spoke in favor of moving Rubino Circle into District 9: Allen Jones, Michael Mulcahy, Kevin Albanese, Mary Ann Brown, Nashell Castello, and Robert Battuello.

The following residents spoke in favor of the 10% variation: Rabbi Menachery Levine, Katie Lam.

The following voiced their concern about property values, school districts and zip codes changing: Nicky Banucci, Kelly Walsh, Holly Barr, and Liz Cochran.

Allen Rice expressed his concern that there are bigger issues to discuss.

Commission questions and discussion of potential population transfer areas continued.

Motion: Commissioner Schumb moved proposal to eliminate transfer areas 6-9a, 6-9aaa and 6-9c.

Action: Motion failed for lack of second.

Motion: Commissioner Fadness moved to remove from the table the motion which carried from the May 2, 2011 meeting to discuss transfer area 6-9d. Commissioner Schumb seconded the motion.

Commission discussion ensued.

Vice Chair Chirco withdrew her motion and Commissioner Shelton agreed.

Commission discussion continued about transfer areas within Districts 6 and 9.

Motion: Commissioner Schoennauer moved a two part motion: (1) to include Commissioner Schumb's proposal as a possible transfer area and (2) that the Commission will not delete any options from the transfer area list tonight. Commissioner Shelton seconded the motion with consideration to give more notice to the Rubino Circle residents to give them an opportunity to be heard.

Action: On the call of the question motion carried. (10-1) (Opposed: Schumb)

Motion: Commissioner Fadness moved to include Bagbey School into District 9.

Action: The motion failed for a lack of second.


